

CONSULTANCY TERMS AND CONDITIONS

These Terms and Conditions ("Agreement") govern the use of the BidBot Ltd web application ("Service") and any associated tools, features, and services by consultancies ("Consultant") and any companies they represent ("Clients"). These terms apply in addition to, and should be read together with, the BidBot Ltd **Terms and Conditions**. By accessing or using the Service, the Consultant agrees to these terms on behalf of themselves and their Clients.

1. DEFINITIONS 1.1. "Service" means the BidBot Ltd web application and any associated tools, features, and services. 1.2. "Consultant" refers to any consultancy firm or individual using the Service. 1.3. "Client" refers to any entity that the Consultant represents while using the Service. 1.4. "Data" means any information, content, or materials uploaded, processed, or generated through the Service.

2. ACCEPTANCE OF TERMS 2.1. By using the Service, the Consultant confirms they have the authority to accept these terms on behalf of their Clients. 2.2. The Consultant warrants that their Clients have granted permission for BidBot Ltd to use, process, and store Data provided through the Service.

3. DATA USAGE AND RIGHTS 3.1. By using the Service, Consultants and their Clients grant BidBot Ltd a non-exclusive, worldwide, royalty-free license to use, process, store, and analyze Data for the purpose of providing and improving the Service. 3.2. BidBot Ltd will implement reasonable security measures to protect Data but does not guarantee absolute security. 3.3. Consultants and Clients must ensure they have the legal right to share Data with BidBot Ltd and that doing so does not violate any third-party agreements or legal obligations.

4. RESPONSIBILITIES OF CONSULTANTS 4.1. Consultants must use the Service in accordance with applicable laws and regulations. 4.2. Consultants must not misrepresent their relationship with Clients or use the Service in a deceptive manner. 4.3. Consultants remain responsible for ensuring their Clients comply with these terms.

5. SERVICE ACCESS AND MODIFICATIONS 5.1. BidBot Ltd reserves the right to modify, suspend, or discontinue the Service at any time without prior notice. 5.2. BidBot Ltd is not responsible for any downtime, loss of Data, or interruptions in service availability.

6. LIMITATION OF LIABILITY 6.1. The Service is provided "as is" without any warranties, express or implied. 6.2. BidBot Ltd shall not be liable for any direct, indirect, incidental, or consequential damages arising from the use of the Service.

7. TERMINATION 7.1. BidBot Ltd reserves the right to terminate or suspend access to the Service for any Consultant or Client found to be in breach of these terms. 7.2. Consultants may discontinue use of the Service at any time, but this does not affect any rights or obligations that have accrued up to the termination date.

8. GOVERNING LAW 8.1. This Agreement shall be governed by and construed in accordance with the laws of the United Kingdom. 8.2. Any disputes arising from this Agreement shall be resolved through negotiation, and if necessary, through arbitration in the United Kingdom.
